 - Bid shall be opened in the presence of Bidders representatives who choose to attend on 20-11-2019 13:00 hours at the office of Dhurkot Rural Municipality Barbot Gulmi Nepal.
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum as mentioned above in table, which shall be valid for 15 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[0910501307701002] Dhurkot Ga.Pa. Dharauti Khata at [Sunrise Bank Ltd., Gairidhara Crossing Kathmandu, Kathmandu, Kathmandu] and submit the receipt of the deposited amount of cash along with the Bid Document.
 - If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
 - The person, firm or company blacklisted as per Public Procurement Act-2063 with amendment, shall be ineligible to submit the bid and also the proprietor of such firm or company shall be ineligible to submit the bid from another new firm or company.
 - Matters not covered by this notice shall be in accordance with Public Procurement Act-2063 with amendment and Public Procurement Regulation-2064 with amendment and other prevailing regulations.
 - The firm or lead partner of the J.V. which intend to apply for ODRM-Gulmi-G-SQ-08-076-77 and ODRM-Gulmi-G-SQ-09-076-77 has to be enlisted in the list of Dolidar, TBSU.
 - The firm or lead partner of the J.V must have the experience of atleast fabrication of Steel parts of one Trail bridge within last 5 years Steel Truss Bridge or Subsended Trail Bridge.
