Bids must be valid for a period of 45 days for ODRM-Gulmi-G-SQ-21-076-77, ODRM-Gulmi-W-SQ-22-076-77 **and 120 days for** ODRM-Gulmi-W-NCB-23-076-77 after bid opening and must be accompanied by a bid security amounting to a minimum as mentioned above in table, which shall be valid for 30 days for ODRM-Gulmi-G-SQ-21-076-77, ODRM-Gulmi-W-SQ-22-076-77 and 90 days for ODRM-Gulmi-W-NCB-23-076-77 beyond the validity period of the bid.
