4. Electronic bids must be submitted through PPMO's e-GP system <http://www.bolpatra.gov.np/egp> on or before **12:00 hrs of 2075/11/05 (17th Feb 2019)**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidder's representatives who choose to attend at **13.00 Hrs on 2075/11/05 (17th Feb 2019)** at the office of Dhurkot Rural Municipality, Gulmi .
6. Bids must be valid for a period as mentioned in table above after the bid opening and must be accompanied by a bid security issued by an authorized bank (A class Commercial Bank) . Security in the form of cash should be deposited in the Deposit account **A/C No.: 0910501307701002**, Account Name: **Dhu.Ga.Pa. Dharauti Khata**, Bank name: Sunrise Bank Ltd dhurkot branch.
